In accordance with the § 19 The Infection Protection Act, free (voluntary) medical counselling and testing (also anonymous) for providers of sexual services continues to be available.

An early diagnosis of any possible diseases can have a positive effect on recovery.

We are sworn to medical confidentiality and all consultations are confidential. We offer testing for HIV/AIDS, syphilis, hepatitis, chlamydia and gonorrhoea.

In case of an infection, treatment under medical guidance is possible. We also provide referrals to infectologists, urologists, gynaecologists, hospitals and other services.

PROSTITUTE AND INFECTION PROTECTION ACT

➤ The Prostitutes Protection Act What does this mean?

Since 01/07/2017, all persons working in prostitution must register their occupation.

Notifiable occupations include working in a brothel, from an apartment, in a lovemobil or as an escort.

Services such as erotic and tantric massage as well as work as a dominatrix are also subject to registration.

If you only work in the following areas, you do not have to register: porn films, peep shows, table dancing, web cam services, phone sex.

Upon registration, you will receive confirmation of registration. You must always carry this certificate with you during your work.

➤ Two-step registration

1. Health consultations

Before issuing the registration certificate, you must attend a personal consultation on health and social issues at the health department of the city of Chemnitz.

Please bring an identity document or substitute passport document with you when you attend.

Health consultation appointments can be arranged by calling 0371 4885361 (weekdays from 09:00 to 11:00).

After the consultation, you will receive two certificates, which you require for registration at the Public Order Office (with your civil name and your alias name).

➤ How long is certification valid?

Health Department:

- under 21 years: 6 months
- from 21 years: 12 months

Consultations and certification at the Health Department are free.

Public Order Office:

- under 21 years: 12 months
- from 21 years: 24 months

You must bring your certificate from the Health Department of the City of Chemnitz with you.
